

In 2017, the North Carolina House continued enacting a commonsense approach to spending that is a paradigm shift in funding our state government.


Properly funding state government allows us to meet essential needs of North Carolinians, look ahead and produce positive investments for North Carolina taxpayers.

The North Carolina House of Representatives repaid – ahead of schedule – more than \$2 billion in debt since 2011. By 2017, North Carolina grew our record savings reserve to \$1.8 billion.

That's a nearly \$4 billion swing in six years.

North Carolina's \$23 billion state budget enacted in 2017 spends over \$13 billion per year on public education and maintains a responsible growth rate in state expenditures.

Our commitment to fiscal responsibility and prioritized investments is saving taxpayers on debt service costs and protecting their investments with a strong rainy day fund.




The 2017-2018 state budget builds a strong foundation for economic success with targeted investments and tax relief for working middle-class North Carolinians.

#### **EDUCATION**

- Increases funding for public education by nearly \$700 million over two years.
- Fully funds K-12, community college and public university enrollment growth.
- Allocates more than \$100 million from lottery funds for grants to economically struggling, rural counties to assist with critical public school




N.C. Education Spending Rising Rapidly



Raleigh, N.C. – Public education spending is rising rapidly in North Carolina under Republican leadership, according to a visual analysis released by the state's nonpartisan Fiscal Research Division this week.

### **EDUCATION CONTINUED**

- Invests an additional \$11 million in textbooks and digital resources and increases funding for children with disabilities.
- Reserves new salary allotment and funding structure for K-5 program enhancement teachers beginning in the 2018-2019 school year.
- Renews the North Carolina Teaching Fellows Program and Teacher Assistant Tuition Reimbursement Program.
- Restores funding to Eastern North Carolina STEM and extends the "TA to Teacher" pilot program in the 14 local school districts originally designated for expansion.

Raleigh, N.C. - The North Carolina Teaching Fellows Commission <u>announced</u> it selected five partner institutions this week based on legislative criteria and an applications process passed into law by the state House of Representatives.

• Fully funds the N.C. Promise Program, New Teacher Support Program, and Future Teachers of N.C.

\$400,000 Coding, App Development Grants Awarded to North Carolina Students




Raleigh, N.C. - The North Carolina General Assembly funded a \$1.2 million Coding and Mobile App Development Program in the 2017-18 state budget that recently awarded \$400,000 to help middle and high school students learn digital skills in public schools.

• Includes over \$18 million in new funding for medical education, including funding increases to the UNC School of Medicine and to the school's Asheville campus.

 Protects the Read to Achieve, Teach for America, and Communities in Schools programs.

• Offers \$2.5 million each year of the biennium to support doctoral programs at North Carolina A&T University.

- Funds \$1.2 million Coding and Mobile App Development Program
- Provides \$2.5 million to assist colleges with start-up costs for high-cost workforce training programs.
- The state budget also guarantees fixed-rate tuition for students at public universities within the state.




N.C. Republicans Remove Cost Barrier to College Credit, More Students Succeed



Rateigh, N.C. - Student participation and successful performance on Advanced Placement (AP) examps in North Carolina have increased substantially since the Republican-led General Assembly began funding the college credit testing flees in 2014, eccording to data provided by the State Board of Education this month.



• The state budget funds college-credit exam fees for students taking Advanced Placement and International Baccalaureate courses.



• North Carolina has had a 22% increase of students taking college credit exams, a 29% increase in the total number of

exams taken and a 19% increase in successful testtakers since the state began funding exam fees in 2015.





#### Growth in Underrepresented Examinees

The mission of the Partnership between The is to prepare, inspire, and connect students to postsecondary success and opportunity, with a particular focus on minority students and students who are underrepresented in postsecondary education.

- > AP participation and performance for Black and Hispanic students in North Carolina's public schools continues to outpace the participation and performance for Black and Hispanic students seen nationwide.
- College Board and the state of North Carolina > The number of Black AP Exam-Takers in North Carolina's public schools increased 5.9% from 2016 to 2017, as compared to a 5.0% increase in Black AP Exam-Takers in public schools nationwide.
  - >The number of Hispanic AP Exam-Takers in North Carolina's public schools increased 13.5% from 2016 to 2017, as compared to an 8.8% increase in Hispanic AP Exam-Takers in public schools nationwide.


- Directs \$1.5 million to the Cheatham-White Scholarship • Program, provides state matching funds for up to 20 scholarships at both North Carolina Central University and North Carolina A&T University.
- Adds over \$3 • million to expand the NC Works Career Coaches Program in community colleges.



Provides \$2 million for Short-Term Workforce Training in • community colleges.

### HEALTH AND HUMAN SERVICES

- Upgrades the Controlled Substance Reporting System that will use advanced analytics to detect and fights prescription drug abuse.
- Allocates \$15 million to community health centers, rural clinics, and free clinics to assist the underinsured.
- Invests \$18 million to improve North Carolina's child



welfare program, including new training and prevention programs, and nearly \$4 million to improve accountability and oversight of the system.

- Directs \$3 million in additional support for foster children.
- Designates \$10 million for opioid and substance abuse treatment.
- Allocates \$19 million from the sale of Dorothea Dix to fund behavioral health beds.

### HEALTH AND HUMAN SERVICES CONTINUED

- Continues preparing for the transition to Medicaid reform by allocating \$75 million to grow the Medicaid Transformation Reserve.
- Includes more than \$12 million for 400 new innovation waiver slots for people with intellectual and other related developmental disabilities that are at risk for institutional care.
- Provides more than \$27 million over two years to add 3,525 new pre-K slots – eliminating 75 percent of the waitlist for at-risk children.

Speaker Moore Responds to President's Declaration of a Public Health Emergency



Raleigh, N.C. – North Carolina House Speaker Tim Moore responded to President Donald Trump's declaration of a public health emergency in the opioid addiction epidemic Friday:

### **AGRICULTURE AND NATURAL RESOURCES**

- Increases funding for the Clean Water Management Trust Fund, Tobacco Trust Funds, and Agriculture Development and Farmland Preservation Trust Fund.
- Expands support for the aquaculture industry and provides funding for dredging to ensure valuable economic activity on the coast can continue.
- Allocates over \$750,000 to expand international marketing of North Carolina agriculture products.

GenX Treatment & Transparency Proposal Approved by North Carolina House




Raleigh, N.C. - On Thursday the North Carolina House of Representatives approved local funding and administrative accountability measures to begin addressing the discharge of the chemical GenX into the Cape Fear River.

- Provides funding for engineers to improve dam safety and review emergency action plans to help prevent catastrophic flooding.
- Sets aside \$2.3 million to purchase a new firefighting aircraft in the wake of devastating wildfires in Western North Carolina.
- Provides more than \$400,000 to local utilities in Southeastern North Carolina for GenX contaminant water treatment and testing in the Cape Fear River.

### TRANSPORTATION

- Increases funding for the Strategic Transportation Investments Program (STIP) by \$320 million, allowing 100 new highway projects to be added over a ten-year period.
- Includes \$241 million to improve structurally deficient bridges, adds \$143 million to improve the condition and safety of existing roads.
- Increases contract resurfacing by \$20 million and increases funding for pavement preservation by \$30 million, extending the life of thousands of miles of roads.




• Invests \$100 million to fund immediate need construction projects that improve mobility and safety, reduce congestion and spur economic development.

#### **TRANSPORTATION CONTINUED**

- Includes \$208 million over two years for a Roadside Environmental Fund dedicated to ensuring the safety and beautification of the state's highways.
- Modernizes the state's transportation network by providing additional funding to airports across the state for infrastructure improvements, and to the State Ports

Authority for infrastructure and dredging needs.

 Provides recurring annual funds up to \$45 million to the North Carolina State Ports Authority for new cranes, expansion of ship berths and basins.



### **SALARIES AND BENEFITS**

- Passes a fourth consecutive teacher pay raise, investing more than \$100 million in the first year, in addition to substantial teacher pay raises in 2014, 2015 and 2016, dramatically increasing educator pay in North Carolina.
- Incorporates a new plan to let highly-qualified new teachers begin at a higher pay grade on the salary schedule.
- Provides financial incentive to teachers who accept positions in low-performing schools, are licensed in special education or STEM classes, or meet other criteria.



\$10,000 Raise Since 2014 for N.C. Teachers Starting 11th School Year



Raleigh, N.C. – Teachers starting their eleventh year in North Carolina public schools received a \$10,380 pay raise since 2014, a 32% salary increase provided by the Republican-led General Assembly.

- Ensures average teacher pay in North Carolina is \$50,000 and starting teacher pay \$35,000.
- Includes roughly \$25 million to expand a performancebased bonus program to top-performing 4th and 5th grade reading teachers and 4th-8th grade math teachers.
- Allocates \$10 million for a bonus program for veteran teachers with more than 25 years of experience.
- Scheduled and reserved future funds for a fifth consecutive teacher pay raise in 2018 state budget.

### **SALARIES AND BENEFITS CONTINUED**

- Provides a \$1,000 salary increase to state employees.
  - 2014-'15 budget provided \$1,000 raise to all state employees
  - 2015-'16 budget provided \$750 bonus to all state employees
  - 2016-'17 budget provided 1.5% raise + 0.5% bonus to all state employees
- Designates \$4 million to increase the base salary range for state workers.
- Provides more than \$35 million to substantially increase principal and assistant principal pay.
- Provides \$10 million in the biennium toward hard-to-hire positions across state government, such as health care technicians and nurses.

for correctional officers, bringing total commitment to more than \$700 million over the next 10 years.

### JUSTICE AND PUBLIC SAFETY

- Begins the process to "raise the age" of juvenile jurisdiction in North Carolina, ensuring 16 and 17-year olds suspected of misdemeanor offenses and less serious felonies would be tried as juveniles instead of adults by December 2019.
- Establishes a Juvenile Jurisdiction Advisory Committee to develop specific plans for implementation.
- Strengthens laws against human trafficking and funds signage to increase awareness of the warning signs of trafficking.
- Funds needed additional positions in the state court system, including dozens of new deputy clerks of court and assistant district attorneys.
- Provides more than \$4 million for law enforcement training for North Carolina officers.

### **GENERAL GOVERNMENT**

- Brings the rainy day fund to \$1.838 billion, or 8.2 percent of last year's state budget – the largest dollar amount and percentage in North Carolina history.
- Adds \$125 million to make needed repairs and renovations to state and university facilities.
- Aims to make government operations more efficient by investing in a fully-consolidated statewide Enterprise Resource Planning system.
- Continues the commitment to improving government transparency by funding a website that makes every state agency, county, and local school district budget available for citizens to view online.
- Adds \$125 million to make needed repairs and renovations to state and university facilities.


# Tax Reform

In 2017 the North Carolina House of Representatives continued to reduce the tax burden on families and small businesses by **cutting the personal income tax rate** from 5.499 to 5.25 percent by 2019.

# Tax Reform Continued

The North Carolina House of Representatives also provided tax relief by **lowering the corporate income tax rate** from 3 percent to 2.5 percent in 2019.

The North Carolina House has maintained **a 1% lower sales tax rate since 2011** of 4.75%.

The 2017 state budget **simplifies and reduces the franchise tax on small businesses** by cutting what is effectively a statewide property tax and **creating a flat** \$200 tax on the first \$1 million of a business's net worth. North Carolina House Speaker Tim Moore

1.5M Working North Carolinians Are Exempt from Income Tax by 2019, 30% of Returns



Raleigh, N.C. - The state Department of Revenue predicts 1.5 million working North Carolinians will not owe state income tax on their earnings by 2019, primarily middle to low-income earners filing 30% of all returns.

# Tax Reform Continued

By 2019, tax relief this decade will exempt more than 350,000 working adults – primarily low-income individuals and families – from owing any income tax.

Cooper Administration: Republicans Protect 241,000 From Income Tax



Raleigh, N.C. - Officials at Gov. Roy Cooper's Department of Revenue confirmed this week that Republican-led tax relief protects hundreds of thousands of low-income North Carolinians from paying any income tax by 2019.

More than 1.5 million total working North Carolinians will fall into the state's zero-tax bracket by 2019 and owe zero personal income tax on their earnings.

That's a 23% increase in North Carolinians whose earnings are exempt from state income tax since 2011.

"The Republican-led General Assembly in North Carolina has kept its promises to North Carolinians by passing historic income tax cuts this decade, growing the economy and benefiting the bottom-lines of average and low-income working families across the state."

### H.B. 13: Class Size Requirement Changes

Goals:

• Provide flexibility to allow public schools to achieve smaller class sizes in first, second, and third grades.

Summary:

- Allows districts to comply with the district average of 20 students per class and an individual class maximum of 23 students for the 2017-18 school year.
- Requires public schools in 2018-19 to meet the class size reduction targets required before H.B. 13.
- Adds accountability measures that require local superintendents to report information on student/teacher rations.

### H.B. 534: Computer Coding Elective Course

Goals:

• Allows students in North Carolina public high schools and middle schools to take computer coding as a course elective.

Summary:

• Directs the State Board of Education "to identify and develop academically rigorous courses in computer programming" that would be offered as electives to middle and high school students.

### H.B. 527: Restore/Preserve Campus Free Speech

Goals:

• Protect free expression and affirm the authority of the U.S. Constitution's First Amendment and the value of free expression at North Carolina's public universities.

Summary:

- Emphasizes the importance of institutional neutrality for protecting freedom of speech within the University of North Carolina system.
- Establishes a special UNC Board of Governors committee to write a comprehensive policy and annual report on campus free expression.
- Requires sanctions for students who interfere with others' rights to open expression while preserving due-process for those accused of suppressing free speech.

"Intellectual diversity and free expression are cornerstones of higher education, and the Campus Free Speech Act ensures North Carolina's world-class university system remains a hub of ideas and open debate."

#### H.B. 339: North Carolina Teaching Fellows Program

Passed in the Appropriations Act of 2017, S.B. 257

Goals:

• Provide a student loan forgiveness program for educators in STEM (Science, Technology, Engineering, and Math) subjects who commit to teaching in the state.

Summary:

- Co-sponsored by more than 70 members of the North Carolina House of Representatives.
- The loan forgiveness would cover tuition, books and fees for STEM and special education teachers in North Carolina.

#### H.B. 450: Future Ready Students Act

Passed in the Appropriations Act of 2017, S.B. 57

Goals:

• Provide workforce training and improve career readiness for students seeking jobs.

Summary:

- Allows high school students to receive academic credit for pursuing career certifications and/or credentials required by either an industry or the state.
- Establish business advisory councils to identify economic and workforce development trends and that may improve training and contribute to learning needs of the local community.
- Establishes the Career and Technical Education Grade Expansion Program to support local education services.
- Requires local boards of education to offer on-the-job training through an internship, cooperative education, or an apprenticeship program.
- Provides \$4.9 million to establish a competitive grant program to expand CTE programs to 6<sup>th</sup> and 7<sup>th</sup> grade students.

### **H.B.534: Computer Coding Elective Course**

Goals:

• Allows students in North Carolina public high schools and middle schools to take computer coding as a course elective.

Summary:

• Directs the State Board of Education "to identify and develop academically rigorous courses in computer programming" that would be offered as electives to middle and high school students.

### H.B.620: UNC Capital Projects

Goals:

• Authorize funding and construction of capital improvement projects by the constituent institutions of The University of North Carolina.

Summary:

- Allows construction of listed capital improvements at Eastern Carolina University, Elizabeth City State University, North Carolina Central University, University of North Carolina at Chapel Hill, University of North Carolina at Greensboro and Western Carolina University.
- The proposed projects are not a debt of the State of North Carolina



• Require driver instruction on law enforcement procedures during traffic stops.

### H.B. 280: Juvenile Justice Reinvestment Act ("Raise the Age")

Passed in the Appropriations Act of 2017, SB 157

Goals:

• Raises the age of juvenile jurisdiction in North Carolina to include 16 and 17-year-olds accused of nonviolent crimes.

Summary:

- For serious crimes classified as A-E felonies in North Carolina, 16 and 17-year-olds could still be tried as adults in the state court system.
- Violations of motor vehicle law would also remain excluded from juvenile jurisdiction.
- Provides victims an opportunity to request reviews of decisions not to file juvenile petitions and increases the information available on juveniles for court proceedings.
- Authorizes statewide school-justice partnerships, requires juvenile justice training for law enforcement officers, and provides enhanced sentencing for offenses committed as part of criminal gang activity.
- Establishes a Juvenile Jurisdiction Advisory Committee.

#### H.B. 551: Strengthening Victims' Rights

Goals:

• Amend the North Carolina Constitution to provide better protections and safeguards to victims.


### H.B. 589: Competitive Energy Solutions

#### Goals:

• Revisions to North Carolina's energy rules that modernize state policy to protect ratepayers with competitive costs and encourage the continued development of renewable power sources.

#### Summary:

- Implements a competitive building process for solar developers to control costs and foster market-drive solutions for power customers.
- Ensures residential, commercial, and industrial customers continue to have access to affordable, clean, and reliable energy with a free-market approach.
- Creates a Green Source Rider Program that allows large utility customers to purchase the type of energy that make the most sense for their customers and employees.



New Energy Law to Protect Customers, Power Economy in North Carolina



Rateigh, N.C. - Major revisions to North Carolina's energy rules became inw on Thursday moderning state policy to protect interpayers with competitive costs and encourage the continued development of reviewable power sources.

- Creates a solar leasing program where customer can work with private parties to take advantage of a competitive market to install renewable energy.
- Encourages innovation of renewable technology by requiring providers to compete for lower prices and more favorable sitting locations when they connect to North Carolina's power grid.
- 18-month moratorium on wind power development to study the impacts of turbines on military operations.

# **Disaster Recovery**

#### H.B. 2: Disaster Recovery Act of 2016

- Appropriated \$100 million for wildfire recovery, hurricane and tropical storm relief efforts:
  - \$37,950,000 to the Department of Agriculture and Consumer Services for disaster-related repairs, debris removal, forest and stream restoration.
  - \$20,000,000 to the Housing Trust Fund to directly benefit persons and families affected by the disasters.
  - \$10,000,000 to the Department of Commerce for local government grants to construct, repair or replace infrastructure of utilities including water, sewer services and sidewalks.
  - \$10,000,000 to the Department of Environmental Quality for wastewater and solid waste cleanup, dam safety, emergency permitting and repair of drinking water systems.
  - \$9,000,000 to the Division of Emergency Management to provide additional support meeting short-term housing needs.
  - \$1,000,000 to the Department of Insurance for grants to volunteer fire departments to repair disaster-related damage not covered by federal assistance or insurance proceeds.

# **Disaster Recovery**

### S.B. 338: Disaster Recovery Act of 2017

- Provides an additional \$100 million to aid Hurricane Matthew, tropical storm and wildfire recovery efforts spanning housing, infrastructure, agriculture, and education in communities across North Carolina.
- \$25,000,000 to be allocated to the Department of Public Safety Division of Emergency Management and Lumbee River Council of Government for housing-related matters.

Disaster Recovery Act of 2017 Approved by North Carolina House



Raleigh, N.C. – The state House of Representatives voted unanimously Wednesday to direct \$100 million of disaster recovery funds in the state budget to aid Hurricane Matthew, tropical storm and wildfire recovery efforts spanning housing, infrastructure, agriculture, and education in communities across North Carolina.

- \$30,000,000 to Golden L.E.A.F. to provide grants to local governments for infrastructure repair purposes.
- \$20,000,000 to the Department of Agriculture to stream debris removal and non-farm road repairs.

• \$2,700,000 to the Community College System Office to offset the impact of enrollment declines due to Hurricane Matthew.

• \$22,300,000 to the State Emergency Response and Disaster Relief Fund.

### Savings Reserve H.B. 7: LRC/Strengthen Savings Reserve

#### Goals:

• Continue the ongoing effort by the North Carolina House to save responsibly for future needs.

Summary:

• Provides that the state budget must include a transfer to the Savings Reserve of 15% of the estimated growth in state tax revenues for each fiscal year of the upcoming biennium.


